I am originally from Indiana so I can vouch that there are many sites to see in the city known as the "Crossroads of America". Besides the obvious tourist areas of the Indianapolis Motor Speedway and Hall of Fame Museum (home of the Indy 500 and Brickyard 400 races) and the Victorian home of President Benjamin Harrison, you should also consider visiting the Indiana World War Memorial Plaza – originally built to honor the veterans of World War I. It is a five-city-block plaza conceived in 1919 as a location for the national headquarters of the American Legion and a memorial to the state's and nation's veterans. It includes a collection of 400 military flags, more than 300 of which are from the American Civil War; and an exhibit replicating the radio room of the USS Indianapolis. Another not to miss site is the Indiana State Soldiers and Sailors Monument, the first in the United States to be dedicated to the common soldier and sailor.

For those who enjoy German food and beer, go to the Rathskeller, a 19th century beer hall and restaurant. It was the German Club prior to WWI, you will be amazed at the beer and food! Also, the Slippery Noodle Inn is a large blues bar and restaurant with the distinction of being the oldest continuously operating bar in the state and it is the oldest commercial building in the city. Its tin ceiling dates to 1890 and the oak bar is also over a century old. It housed a brothel until 1953. They serve great chili and beer. I always feel right at home there!

Historian's Message

Since our last reunion in San Antonio, Texas, our memorabilia has grown by 4 items. I am working on getting them inventoried and photographed. I have been sending out "Welcome Aboard" letters to new members and reinstated members. I am also working on getting everyone in one of the Profile binders, these binders are where we have everyone's history for all the membership to read at the Annual Reunion's.

Our military history is very important since our rating is no longer active in the US Navy, this association is truly a "Last NW/GMT/WT Standing" association. One day there will be only one member left. That member will have the responsibility to ensure that all of our memorabilia, history and personal history is turned over to a military museum for others to see, enjoy, and learn about us from.

We now have the Microsoft Access database program up and running. This database will continue to grow as new members join and add their data. Once your information is in the system it is in there forever. Through the Access program we currently have the following reports that we can print out, Rank report, Program entry date (this report helps us identify the Gray Dragon), Member contact list (All past/present members). The Duty station report and the Member contact report includes all past/present members , this does include all past members that have been removed from the Treasurers Roster.

As of 10 December 2015 we have 887

Past/Present members entered in the database. Out of the 887 shipmates 582 are listed with their duty stations. This information comes from the members application form or them filling out the personal profile sheet and mailing it to me. This is why I ask everyone to write your military history down with duty stations and dates in the Navy. That way I can enter your history into the database. But I can ONLY do that if your write it down and email or mail it to me.

A Brief History of Nuclear Weapons States



The world's first nuclear weapons explosion occurred on July 16, 1945 in New Mexico when the United States tested its first nuclear bomb. Three weeks later, the world changed.

On August 6, 1945, the United States dropped an atomic bomb on the Japanese city of Hiroshima. It killed or wounded nearly 130,000 people. Three days later, the United States bombed Nagasaki. Of the 286,000 people living there at the time of the blast, 74,000 were killed and another 75,000 sustained severe injuries. Japan agreed to an unconditional surrender on August 14, 1945; it also resulted in the end of World War II.

In subsequent years, the United States, the Soviet Union and Great Britain conducted several nuclear weapons tests. In 1954, President Jawaharlal Nehru of India called for a ban on nuclear testing. It was the first large-scale initiative to ban using nuclear technology for mass destruction.

In 1958, nearly 10,000 scientists presented to United Nations Secretary-General Dag Hammarskjold a petition that begged, "We deem it imperative that immediate action be taken to effect an international agreement to stop testing of all nuclear weapons." France exploded its first nuclear device in 1960 and China entered the "nuclear arms club" in October 1964 when it conducted its first test. The United States, Soviet Union and some sixty other countries signed a treaty to seek the end of the nuclear arms race and promote disarmament on 1 July 1968. The treaty bars nuclear weapons states from propagating weapons to other states and prohibits states without nuclear weapons to develop or acquire nuclear arsenal. It permits the use of nuclear energy for peaceful purposes. It entered into force in 1970 and was extended indefinitely and unconditionally on 11May 1995.

In 1974, India conducted its first nuclear test: a subterranean explosion of a nuclear device (not weapon). India declared it to be a "peaceful" test, but it announced to the world that India had the scientific know-how to build a bomb.

At this time, the five declared nuclear weapons states are the USA, USSR, UK, France and China. In December, 1986, The South Pacific Nuclear-Weapon-Free Zone was put into effect. American and North Korean delegations met in Geneva in autumn 1994 to establish a framework to resolve nuclear issues in the Korean peninsula. Under the agreement, North Korea would sign a treaty on the non-proliferation of nuclear weapons in exchange for U.S. support in building safe nuclear energy facilities and formal assurance against the threat or use of nuclear weapons by the U.S. against North Korea. Both sides agreed to take steps towards better political and economic relations. In subsequent years, South Korea and Japan have invested billions to help build safe nuclear energy plants in North Korea. By 2003, North Korea has cancelled this and all other international agreements on non-proliferation. The United Nations, on December 12, 1995, decreed an immediate ban on all nuclear testing and urged disarmament with the vision of a world free of nuclear weapons.

Later that month, ten Southeast Asian countries signed the Bangkok Treaty, establishing the Southeast Asia Nuclear-Weapon-Free Zone. In spring 1996, 43 African nations sign the Pelindaba Treaty establishing the African Nuclear-Weapon-Free Zone.

On September 10, 1996, the United Nations, in a landslide vote, adopted the Comprehensive Test Ban Treaty and two weeks later, the United States was the first to sign. The U.S. Senate, however, rejected the treaty three years later.

On May 11, 1998, India shocked the world by exploding three nuclear devices amounting to about six times the destructive power of the American bomb dropped on Hiroshima in 1945. The next day, it tested two more nuclear explosions. The world was stunned when Pakistan responded with six nuclear arsenal tests of its own. World leaders admonished the two long-time adversaries in breaking the Comprehensive Test Ban Treaty put into force in 1970. The U.S. imposed strict economic sanctions against both countries and lobbied for the World Bank. International Monetary Fund and other countries to do the same. The sanctions were lifted in 2001 when the U.S. needed Pakistan and India's support to fight al Qaeda and other terrorist cells in Afghanistan.

In 1998 North Korea alarmed Japan by test-firing a medium range-missile (without weapons) over the Japanese mainland. The missile's apparent range, some 1,000 kilometers or 600 miles, meant that any part of Japan - and by default any part of South Korea - was within range of North Korean weaponry. Japan is the only country ever to have been attacked by nuclear weapons and anti-nuclear sentiment runs particularly deep.

In 2002, American President George W. Bush named Iran, Iraq and North Korea as the Axis of Evil, in part due to U.S. suspicions of those countries having weapons of mass destruction. Later that year, unofficial reports suggest that North Korea has confirmed the existence of nuclear arsenals, and intelligence reports indicate that the dictatorial power will have enough plutonium to build five or six nuclear bombs by May 2003.

On October 9, 2006 North Korea tested a nuclear weapon with the approximated power of the Hiroshima bomb. North Korea announced to the world that it has become the world's eighth declared nuclear weapons state. Its missiles have the range to hit targets in South Korea, Japan as well as U.S., Chinese, and Russian territories. The United States is the only known country to have missiles with range to attack any target on earth, but over thirty countries have unmanned planes that are undetected by missile defense systems, and can carry nuclear, biological or other weapons of mass destruction.

Webmaster's Message

About the first of every month, I do two things that should involve most of the members and a few specific members. First, an e-mail is sent to the general membership listing the web site changes made in the past month as listed on the web site. This gives you a good chance to review the site and to check on your dues status, check to see if any old shipmates have joined, or sadly if any have passed.

Second, and more importantly, the dues expiration list is reviewed for members whose dues have expired. Here is what actions are taken in the event of a member has expired dues:

- On the second month after dues expiration, an e-mail is sent to the member letting them know of the dues expiration and change the web site roster to reflect the delinquency status.
- If the dues are not paid after that, on the second year anniversary, yet another e-mail is sent reminding the member of the dues expiration from the prior year and also the webmaster will remove any

contact information from the web site roster.

• A final e-mail will be sent on the third year anniversary of the dues expiring letting the ex-member know that we have removed their name from the roster.

In each case, I invite them to renew their membership and have a link to the renewal application.

As of this date, we have more than 194,000 hits on the NNWA web site – an average of over 38 hits a day since I started record keeping March 2002.

If you don't get the monthly e-mail and have a good e-mail address, PLEASE, let me know. We don't want to leave you out of any of our communications.


