He also reports that the government is recognizing and improving the lot for those exposed to radiation. If you have any questions as to your Veterans benefits contact Chuck at (215) 822-4329 or e-mail charlesj.weber@fmcti.com_Medical Benefits for Military Retirees: Congress has enacted legislation to provide continuing health care benefits for military retirees past the age of 65. It was recently formally named "Tricare for Life". Tricare is the successor medical benefit program to the formerly well-known Champus. Military retirees will not now have to rely solely on Medicare treatment and pharmacy programs after they reach the age of 65. Tricare for Life will be an option for them. Enrollment will be required and the DEERS system continues to be the vehicle for doing that. Some words of caution. DO NOT cancel your Medicare supplemental insurance policies yet. DO NOT cancel your employer-provided private insurance policies yet. The legislation passed does not start Tricare for Life coverage until October 1, 2001. So keep your current coverage in place until at least then. More information will be available as the program start up date nears. DIABETES - AGENT ORANGE LINK CONFIRMED BY VA. In a recent VA decision, it is now conceded that, for purposes of veterans disability compensation, any veteran who has adult-onset type II diabetes and Agent Orange exposure has a service connected disability. A couple of years ago it was also conceded that any veteran who served in Vietnam, flew over it or served in its contiguous waters was exposed to agent orange. If you are a Vietnam veteran with diabetes contact the VA immediately and file for disability compensation.

Minutes of the General Business Meeting:

President Dee Rochester acknowledged the efforts of Frank and Linda Kelly, this years reunion hosts; for the excellent efforts they accomplished for this years reunion. Again one of the best reunions this association has hosted. The members present stood and applicated their efforts

OLD BUSINESS:

Tom Best read a NNWA history summery he had put together from information provided by some of our long term members. Past Secretary Danny Rider was a large contributor to this effort.

The Minutes of the last meeting were read by the Secretary, and the Members present accepted them by voice vote.

The Treasurer presented an "Interim" Financial report from 1 November, 2000 to 25 September, 2001. The Members present accepted the Interim Financial report by a voice vote. The final Financial report will be completed after the reunion when all bills have been presented and paid. It will be provided as part of the next newsletter.

Tom Best reminded all members to check the date of their dues expiration and to ensure that they are paid up members. He also proudly noted that our NNWA membership continues to grow and we are now at 431 members.

The President discussed the Great American Cook-out that was held this year on Wednesday. It was a great success and attended by 62 persons. He recommends that future Board of Governors consider such a "ICEBREAKER" event early on at every reunion.

The President announced that for the first time, the NNWA Board purchased "Liability Insurance" to cover the Reunion. This was at a minimal cost of \$245.00 and he recommended that future Board of Governors consider liability insurance at all future reunions.

The President brought the members up to date on the effort to update the NNWA constitution. He further recommends that the new Board of Governors continue this effort by looking at all historical NNWA documents; Newsletters, Minutes of Meetings, and other NNWA Correspondence to ensure that all past recommendations and approvals by voice vote are included into the new Constitution. It should be presented to the membership for review and voted on at the next business meeting. (See the item below on Staggering of the Board).

Last year the Board of Governors designed and approved a NNWA Sympathy Card to be sent to all surviving spouses of our members. He recommends that this practice continue.

The NNWA Historian, Mike Snyder discussed the continuing efforts of updating the Navy Nuclear Weapons history as applicable to the NNWA. He acknowledged the early efforts of Shipmate Henry B. Smith who developed a history from the earliest stages of the navy program (1949) to the 1959 era. He is attempting to bring this history up to date. He also acknowledged the treasure trove of information; documents; photo's and equipment provided by Shipmates Roy Norman; O.B. McRenyolds, Jack Hayes, Doug Weaver and Jack Summers. He would also ask that all members of the NNWA contact him with your memories, shipmates stationed with and funny anecdotes from your days in the Nuclear Weapons program. NEW BUSINESS:

The Board of Governors "Service Officer" Chuck Weber provided a in-depth look into the new **Tricare For Life (TFL)** program that the government instituted for military retirees age 65 or greater, commencing 1 October, 2001. If you need further information on this program, Chuck recommends you contact your local county Service Officer, the Veterans Administration offices near you or on the Internet at www.tricare.osd.mil. Chuck also recommends that you contact "The Retired Officers Association" (TROA) as they have a very good book covering the TFL program either by mail of at www.troa.org. Chuck also noted that the government will so be offering Retired Military members a low cost "Long Term Care" insurance

A motion was made form the floor to consider rotating terms for the Board of Governors so that the board did not completely change every two years. The motion was seconded and discussion took place. After the discussion, a voice vote was called and the motion was passed. The Board of Governors will resolve this issue for future revision of the Constitution.

President Dee Rochester mentioned that the Board of Governors authorized the expenditure of association funds to:

- 1. Offset the cost of the Great American Cook-out
- 2. Offset the Dinner costs for the Saturday Night Dinner
- 3. Offset the cost of hosting the Hospitality Room.

He also noted that the association has made a \$500.00 donation to the Federal Employee Emergency Account (FEEA) in the name of the Navy Nuclear Weapons Association. This account is intended to assist Military and Federal employees who have suffered losses due to the 11 September "Attack of America". He also noted that the Fleet Reserve Association (FRA) has instituted a Pentagon Aid Fund and is accepting donations through local FRA Branches and is intended to directly help members who had losses during the Pentagon "Attack on America".

The hosts for the 2002 reunion in Las Cruces, NM. are Bill & Nina Grizzard and Mike & Joyce Seitz. Bill Grizzard provided a short overview of the reunion. The dates will be 24 September through 29 September, 2002. The hotel will be the Hilton in Las Cruces at approximately \$60.00 per night room rates. The reunion will also coincide with the Southern New Mexico State Fair in Las Cruces, so there will be many activities to be able to choose from. He had also negotiated a tour

to "Trinity Site" for the NNWA members at the reunion through the Public Affairs Officer at Trinity. Bill will provide additional information in the next NNWA Newsletter.

President Dee Rochester and NNWA member Ray Margeson discussed the possibility of providing members with a NNWA Business card to carry with them. The card would identify the NNWA on the front and contain a small NNWA application on the back. This would allow members to provide interested prospective members an instant application for membership. It was agreed to look into this.

There was a discussion from the floor concerning the NNWA developing an Internet WEBSITE. It was agreed that members Ray Margeson and Dave Shiffman would look into the development of this website and provide information concerning the development and cost maintenance tot he Board of Governors for approval.

The 1999/2000 NNWA Board of Governors terms have expired. The President Dee Rochester opened the floor to nominations to serve the 2001/2003 Board of Governors. Nominations form the floor included: Mike Snyder; Frank Cantrell; Ray Margeson; Jim Hambley; Chuck Weber; Bill Grizzard; Ella Mae Weaver; Sid Hart; Stephens. (Henry indicated earlier that he would serve as the Chaplain again). There being no other nominations, The floor was closed and discussions were opened. After discussion, a voice vote was called and the membership approved the new Board.

Secretary/Treasurer Comments: Thanks to the efforts of a few of our current members, we have had a very active year in new memberships. I am very happy to report that we now have 431 members of the NNWA. That breaks down to: 33 LIFE members (up from 27 last year); 8 Associate Members and 390 full members. Of the Associate members, 4 whose dues expire in 2001. Of our Full members; 5 are in arrears from 1995; 15 in arrears from 1996; 13 in arrears from 1997; 8 in arrears from 1998; 15 in arrears from 1999, 27 in arrears from 2000 and another 113 whose dues expire in 2001. Past policy has been to drop members who are three years or more in arrears (1995 thru 1999). This is an effective policy mostly due to the expenses of mailing newsletter and reunion information, however with the military close down of our program, and no new prospective membership on the horizon; we as an association need to make a collective effort to ensure that those members who are in arrears are afforded every opportunity to upgrade their membership dues. Please assist us in doing so. Annual dues are CHEAP! \$10.00 annually. Renewals are CHEAP! \$ 10.00 for renewal and \$10.00 for current annual memberships. At these costs, if all members in arrears would catch up their membership to year 2002, we would bring in an additional \$1420.00 to the association bank account. The same applies to our Associate members. Additionally, if each member renewed their membership annually that would provide us with approximately \$1130.00 in operating expenses. That would increase our treasury by \$2720.00. Although as an association we are financial stable this year, in the near term future, with the lost of members from non-payment or death, and the lack of new membership due to the demise of the nuclear weapons program; in the out years we will be financially strapped. Reunions are basically self supporting, but not without a tremendous amount of volunteer efforts from our on-site Chairperson and his volunteer staff. The Hospitality room is normally the major expense provided by the association, but the registration fees and the collection jar at the bar helps offset this cost. (Don't Forget To Drop a couple Dollars in the Jar). Thanks to Frank & Linda Kelly, plus all the others who assisted in this years reunion we were not financially hurt. But unless we, as an association and as individual members do not actively seek and enlist new memberships constantly, this
