<u>Historian's Message</u>

Merry Christmas and Happy New Year Shipmates!

As your new Historian I approach the position with some since of trepidation in the shoes I am to fill, but look forward to the challenge. As I am a different person my approach may be different than those of the past but be assured, I look forward to looking at and sharing the fascinating history of Nuclear weapons and the US Navy.

A little bit info about me: I'm originally from Southern Utah, spent my youth in the mountains and red rocks of Utah. When I graduated High School, I immediately enlisted in the Navy and went to boot camp in San Diego: my commands included: USS Oklahoma City CLG5, USS Badger FF1071, NWTGP, USS Constellation, USS L.Y. Spear, NWS Yorktown, USS Enterprise and SWFPAC. I had split in service after Yorktown when I got out of the Navy and I became a Newport News City Police Officer. After that I went back into the Navy and headed to NAVETS and then USS Enterprise.

After being bought out of my contract during the downsizing in 92, I moved back to Utah and I became a full-time student and graduated from the University of Utah with a BS in History and Secondary Education. I moved to Texas and taught 8th grade US history and civics for 25 years until I recently retired from that. During that time, I earned my Master's degree in Education Administration, and then finding that totally useless I earned a Masters degree in Military History. I retired from teaching in May of 2021 and here I am your new Historian. Anyway, enough about me.

My first article I think will be about the Regulus weapons system: the Mk5 and the W27. I have always been fascinated by that weapons system and the platforms, particularly the subs that carried it. So, I think I shall look at that. Unfortunately, that was before my time but still I am fascinated by it.

Development of the Regulus Cruise missile SSM-N-8 began in 1947 by the United States Navy and Chance Vought Aircraft. This unmanned turbojet

powered vehicle system was capable of delivering a 3000 pound Mk5 warhead with a 40-50 kt yield or a later developed 2800 pound 1-2 megaton W27 nuclear warhead within a range of 500 nautical miles after being launched from a submarine as well as carriers and cruisers.



Regulus became operational in 1955, eventually serving aboard diesel and nuclear powered submarines, cruisers and aircraft carriers. Regulus was first deployed by the US Navy in 1955 in the Pacific onboard the cruiser USS Los Angeles CA-135. By 1956 the surface launched Regulus was deployed onboard specially designed diesel powered submarines. The USS Tunny SSG-282, and USS Barbero SSG-317 were our nations first nuclear deterrent patrol submarines. They were later joined by three additional Regulus submarines, USS Grayback SSG-574, USS Growler SSG-577 and the nuclear powered USS Halibut SSGN-587.

The Mark5 warhead: A look at the warheads shows us that the older Mk5 warhead was a much smaller yield. As the first lightweight nuclear weapon, the Mark 5 also made it possible to consider placing atomic warheads on smaller missiles, and in 1954 a number of Mark 5 bombs were modified slightly to fit inside a small space and mounted onto Regulus missiles. The Mk5 was a smaller and lighter implosion weapon than previous designs. The Mk 5 was the first lightweight strategic nuclear bomb. Its weight

was one half of Fat Man, in fact it was an improved version of the Fat Man bomb.

The W-27 was the warhead derivative of the first lightweight thermonuclear bomb, which began development in May 1955. Twenty warheads were produced. The W-27 weighed 2,800 pounds and had a yield of 1-2 megatons. The decision to use the W-27 warhead necessitated the only major structural change in the Regulus I design. The nose section of the tactical missile was redesigned with a bulged nose to accommodate the W-27. The W-27 was finally retired in July 1965
